Subject: STATE EXAMINATION – FIRST SCHOOL CYCLE

The First School Final State Examination practically concludes a training and orientation path, aimed to developing individual potentialities (compared with the different initial levels of each student). It is fundamental that the examination is an educational training experience. Therefore, it has to be carried out following a tailor-made path, in the respect of competences, attitudes, aspirations.

The organization is as follows:

- ✓ an interview has been implemented to allow Students to present to teachers the Work they have elaborated.

Every Student is asked to transmit one's Work through the Classroom Platform within **June 8<sup>th</sup> 2020**

Students will be supported by their Teachers in the elaboration of their own Works; they are asked to have assume a proactive and productive behavior

- ✓ The exposure interview will take place using a video meet (specifically through the Meet/Gsuite Application). The corresponding evaluation will not concern the different subjects individually (for which four-monthly evaluations are considered valid) but transversal competences.

Quality of the realization of the work

Quality of the accompanying documentation

Argued exposure of contents and use of different languages (both verbal and non-verbal languages)

Interdisciplinary links and personal evaluations / reflections.

In the future days, Reference Teachers (“Coordinatori”) will give their Students a calendar of the presentation of the Students' Works. The Calendar will be published in the Electronic School Register (Registro Elettronico) in following section; “Communication to the Parents” (“Comunicazione ai Genitori”).

The final Exam Evaluation and the correspondent mark, which is expressed in tenth, following factors will be considered:

- ❖ Overall Evaluation of the three-year course (**60%**)
- ❖ Evaluation II quarter 2019-20 School Year (Distance Teaching “Didattica a distanza” (**20%**))
- ❖ Evaluation of the Work, as indicated in the Disposition issued by the Ministry of Education May 16<sup>th</sup> 2020

Evaluation of the Work produced (**10%**)

Evaluation of the Exposure (**10%**)

Final results will be published on Friday, June 26<sup>th</sup> 2020

Students's parents or a duly or an adult person (being 18 years old is a requirement) with an official proxy may withdraw the Diploma “**certificato di Licenza**” from the School Secretary “**segreteria della scuola**” – **via Giacosa 46** – since Monday, **June 29<sup>th</sup> 2020**
